Introduction

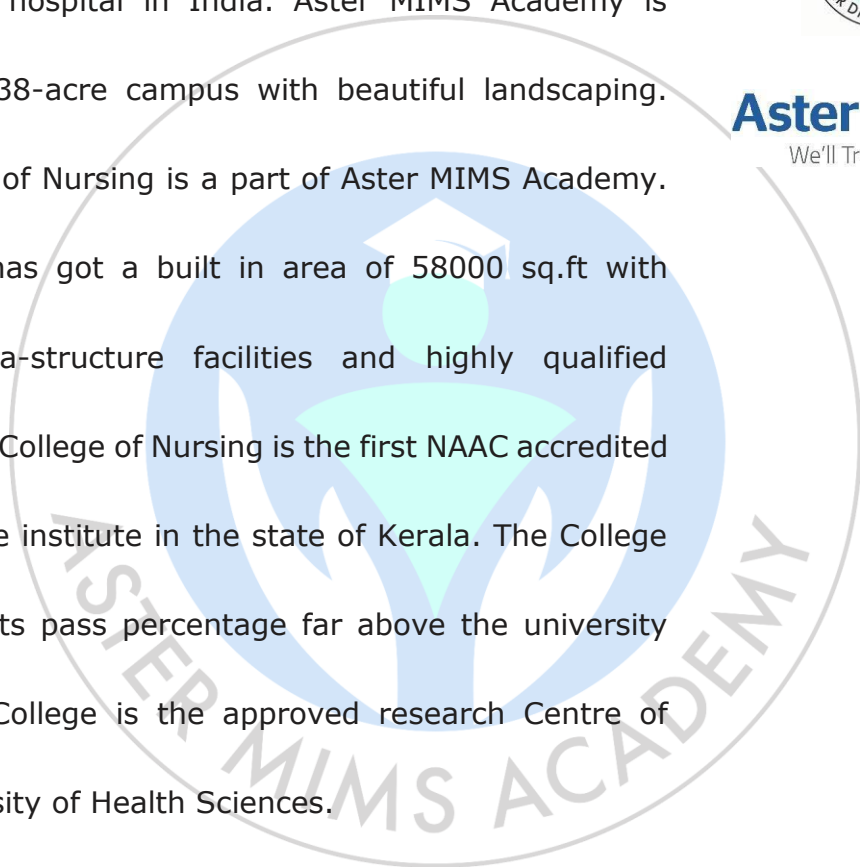

Programme goal

This course aims to prepare nurses who can make independent decisions in nursing situations, protect the rights of and facilitate individuals and groups in pursuit of help, functioning the hospital, Community nursing services and conduct the research studies in the area of nursing practice. They are also expected to assume the role of teacher, Supervisor, and Manager in a clinical/Public health checking/School of Nursing.

Philosophy

We, the staff of the College of Nursing, MIMS believe that caring for human being is multifaceted. We believe that each individual is unique and as health care professionals we are obligated to provide holistic care.

3. Practice as Clinical Nurse Specialist.
4. Establish collaborative relationship with the members of other disciplines.
5. Assume leadership in various care settings.
6. Participate in health planning, implementation and evaluation at different levels of health care system.
7. Function as effective nurse educators and nurse managers.
8. Conduct independent nursing research and utilize the research findings in nursing practice and education.
9. Critically evaluate various educational programmes in nursing.
10. Demonstrate interest and positive attitude in continuing education for personal and professional growth.

Regulations

IV. Selection & admission of candidates

a) Admission

Annual admission for M.Sc (N) Programme should have prior sanction/permission from the Indian Nursing Council, Kerala Nurses Midwives Council & University on the basis of clinical, physical facilities and teaching faculty.

b) Eligibility Criteria/Admission Requirements:

1. The candidate should be a Registered Nurse and Registered Midwife with Kerala Nurses and Midwives Council.
2. The minimum educational requirements shall be the passing of regular degree course in Nursing – (B.Sc. Nursing / B.Sc. (Hons). Nursing / Post Basic B.Sc. Nursing), with minimum of 55% aggregate marks, in an institution which is recognized by Indian Nursing Council.
3. Minimum one year of experience after Basic B.Sc. Nursing. One year compulsory nursing service/internship after successful completion of four year B.Sc Nursing can be considered as experience.
4. Minimum one year of experience prior or after regular Post Basic B.Sc. Nursing.
5. Candidate shall be medically fit.
6. Relaxation of marks for SC/ST candidates may be given as per state government norms.

Curriculum Design

The curriculum is focused on transactional model of education and nursing process approach. This programme (BSc (N)) will take place over four academic years. This course is divided into a number of subjects which are separately assessed and must be individually passed.

Remittance of Application Fee and Submission of Application Form

Stage3- Completion of Application and submission to the college through online. No need to send any printout of the data to the College office.

IV. Preparation of Merit List

Meritlist:

(a) Management seats will be filled by managements from among the applications received by the College on the basis of merit list prepared based on the marks obtained in the qualifying examination.

(b) Out of 50% management seats 15% NRI seats shall be filled up from qualified students as per G.O (MS) No.243/2014/HRFWD dated 6.08.2014 of Govt. of Kerala. The original documents shall be submitted at the time of admission.

Validity of the merit list:

Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicant satisfy the rules regarding the eligibility for admission and other conditions as laid down in the Prospectus.

Furnishing of false information/particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

Admission & Payment of Fees

The selected candidates will be informed through SMS in to the registered mobile number with us.

The students shall pay all fees of the first year of the course at the time of admission.

Fee stipulated by the Fee Regulatory Committee/Govt. of Kerala is applicable along with other fees.

Special Fee: 55000/-

Collection of tuition fee, special fee etc. should be as prescribed by the Fee Regulatory Committee (FRC). Pending issue of orders regulating fee by the FRC, the College is allowed to charge the tuition fee and other fees applicable to similarly situated colleges.

VII. Special Instructions.

(a) Ragging: Ragging in any form is strictly prohibited in MIMS College of Nursing. Hence any student who indulges in any form of ragging will be subjected to penal action as per provisions of law. Also the student will be expelled from the college as detailed in the law concerned and as per Honorable Supreme Court of India directions in this regard.
